Protest: in writing within 20 minutes from the event, fee: 50 €

Prizes: The first 3 seniors (male and female), juniors and seniors 65+ will get cups.
The best females and juniors will be awarded if minimum three competitors will participate.

Liability: All competitors compete at their own risk. The organizer cannot be held responsible for any and all damages, injuries caused by any competitor, to other competitor, third person or subject.

Local rule and rule clarification:

1. The motor restart is allowed during the competition.
2. Based on the SC4_CIAM General_Rules_2022: B.1.1 e) and SC4_Vol_F5_Electric_24-v2: 5.5.11.1.1. and 5.5.11.1.3. requirements:
Except for the approved AMRT, the installation and use of following electronic equipment is not allowed:
Gyroscopic System, Variometer, GPS equipment, including receivers with these function built in.

Safety regulations:

1. Competitors over 18 years of age must have an UAV A1-A3 drone training certificate.
Competitors under 18 years of age may only fly with adult supervision.
2. Models:
 - Battery charge and internal resistance value must be adequate.
 - Fail-safe mode must function properly.
3. Flight area
 - Outside of the competition, flying is only allowed east of the start area, as there is also manned aircraft traffic at the airport.
 - Flying or thermalling over airport buildings and parked aircraft is prohibited.
 - Since a manned aircraft or rescue helicopter may arrive at the airport at any time, the competition director may order the models to land at any time.

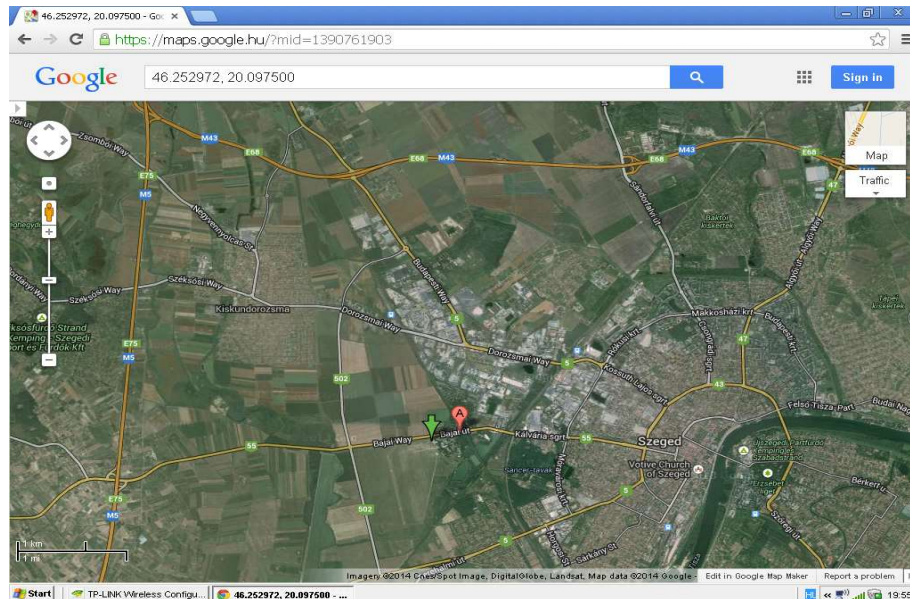

Map:



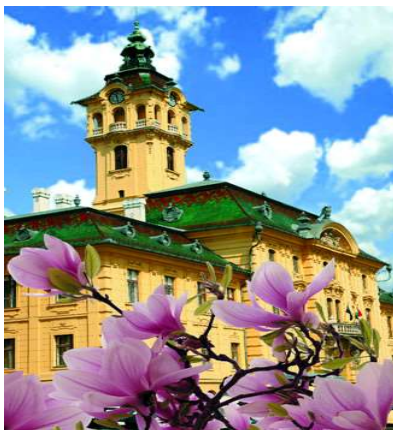
